A MINISTRY COVENANT

among

ABOUT THE FOUR-WAY COVENANT

The United Church of Christ advises that in instances where Commissioned Ministers are called to non-parish employment, a covenantal relationship be established among the Commissioned Minister, the calling body, the United Church of Christ as represented by an Association or Conference, and the Local Church where the Commissioned Minister is a member.

This is known as a "Four-Way Covenant" and it is motivated by the conviction that Commissioned Ministers in non-parish settings need to be active and participating members of a Local Church and that calling bodies have a responsibility to the ecclesiastical system.

PURPOSE

The purpose of this covenant is three-fold:

1. To strengthen, support, and sustain the ministries of all the partners that share in this covenant.
2. To encourage mutual participation and accountability of and for the life of each by the others.
3. To observe, nurture, celebrate, and call forth the ministry of the Authorized Minister.

TERMS

[Minister] serves as [ministry title or descriptive term] with/for/of [name of calling body]. The terms of her/his ministry are given in his/her letter of call from the [calling body], dated [date].

S/he will be invited by [name of Local Church] to participate in the life of the congregation as the need presents itself and as his/her time allows, as well as to receive support and encouragement in her/his ministry from members of the congregation.

As a Commissioned Minister with standing in the Northern California Nevada Conference, [name of Minister] will be bound in the covenantal ties of mutual accountability and support, including periodic reviewing of the mutual faithfulness to this covenant from the perspective of each member of the Four-Way Covenant.

Obligations of compensation and employment exist exclusively between [name of Minister] and [name of Calling Body].

This four-way covenant will exist as long as [name of Minister] serves as [title] with [name of Calling Body] and all partners agree with the covenant as stated.

We believe that this covenant is ordained by the Holy Spirit working among us, and we will labor diligently and faithfully to make it effective. We enter into this covenant with a deep conviction that ministry is rooted in the Local Church and is extended outward through concern and care for the larger Church and the world. It is in and through the community of the Church, the Body of Christ, that we discern our calling and are supported to live out our lives in faithfulness to that call. We believe that our mutual ministry is strengthened by this covenant. We trust in God's presence with us as we seek to be faithful to this covenant.
